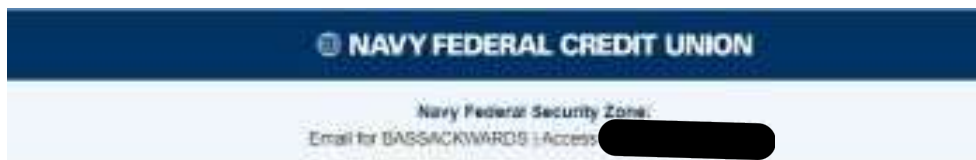

### SECTION VI: Blast-Off

- A. Blast-off will be conducted in the following manner:
  - 1. The Tournament Director will conduct a safety brief to include, but is not limited to, (1) Official time, (2) Time of weigh-in, (3) Limit regulations, (4) Life jackets and kill switch must be on and engaged, respectively, when the boat is on plane, (5) and any other information he deems necessary. Upon completion of the safety brief he will announce the blast off order and answer any questions. He will then be allowed to blast off first.
  - 2. The last boat in the blast-off order will call out the remaining boats to blast off in their respective order.
  - 3. All boats that blast-off will do so, in order, only when their stern is clear of all other club member's boats. This is to ensure that no unsafe conditions develop for members waiting to blast off.
